

It is almost like a twisted season of Fargo (which is a compliment). A woman is brutally raped and murdered in a small Nebraska town (Beatrice). The crime goes unsolved for four years. Then deputy of questionable reputation (a failed pig farmer) picks up the case. Through deception and coercion, one suspect after another is forced to turn against others, confession and implicating the others. Only one of these alleged perpetrators digs his heels in and claims his innocence. It is a spiderweb of unfounded accusations and confessions that have nothing to do with the physical evidence. Outstanding work here. He takes us through the eventual release of these perpetrators and the pursuit of the real killer. I was riveted through the entire book and the level of detail provided is outstanding. Failure of Justice should be required reading in law schools as a lesson in what not to do.

Excellent, I enjoyed the in-depth, detailed description and explanation of exactly how human nature, human failure, human weakness and the hindrances of a legal system and laws, can combine to steer evidence and unscientific investigation in the wrong direction. 6 people ended up having their freedom taken from them for many years and their lives irrevocably altered as a result. A very frightening situation and made more so because once you are ensnared in such a situation, you are at the mercy of fate and happenstance.

This was an amazing story about 6 people in Nebraska who were wrongfully convicted or were frightened into taking a plea deal in the vicious murder of 68 year old Helen Wilson in her 2nd floor apartment during the night of February 5, 1985. Three men and three women, some with a history of mental illness, were sent to prison over it, some for nearly 20 years. But after DNA testing became commonplace it ultimately proved that all 6 were completely innocent in the case. The case had gone unsolved for 4 years by the local police in Beatrice, Nebraska. Then a former local cop who had quit to take up hog farming decided he was going to make them look lame by solving the case himself. He was eventually hired by the Sheriff of the county and got the go-ahead to take the case on. His misdirected investigation ended in the arrest of the 6 people later called "The Beatrice 6". Most of them denied any involvement but were eventually persuaded with threats of the electric chair to confess. A lot of failures happened in many areas for this whole thing to go through, such as bad polygraph readings, bad reading of DNA test results, false confessions and ignored exculpatory evidence.
