

She was a member of the Executive Committee of the World Federation of Orthodontists from 2000 to 2010. She is an Honorary Member of the Argentine, Chilean, and Polish Orthodontic Societies and in 2010 became a member of the National Academy of Dentistry. Also in 2010 she was named Woman of the Year in Medicine and Healthcare. Dr. Harfin is the author or editor of several previous books, including Achieving Clinical Success in Lingual Orthodontics (Springer, 2014).
