

## Synopsis

Evidence-Based Reading for grade 4 offers 64 pages of reading practice. It is aligned with the Common Core State Standards and includes a reading comprehension rubric, a standards alignment chart, and pages of reading passages with evidence-based questions to encourage higher-level thinking and thoughtful answers. Each question is designed so that students learn to support their answers with evidence from the text. A variety of literature and informational passages are included to engage learners in a range of texts. The Applying the Standards: Evidence-Based Reading series emphasizes close reading by requiring students to answer text-dependent questions in both literary and informational texts. This is a series of six 64-page books for students in kindergarten to grade 5. Various reading and vocabulary skills are covered, and a culminating reflection question for each passage engages students' higher-level thinking skills. Of particular emphasis throughout the series are the Common Core State Standards and the teaching of evidence-based reading.

Applying the Standards: Evidence-Based Reading provides students with the practice they need to closely and carefully read both literary and informational texts to support comprehension and critical thinking skills. Also included in this book is a Common Core alignment chart, a rubric for assessing reading comprehension, and an answer key for easy planning and implementation.

Of all the Denilian handwriting workbooks, this one shows the most correct forming of the letters. The only thing it does not show correctly (in my own personal opinion) is the starting area for each letter, but that is easily corrected with a thin sharpie. My students were very eager to start learning cursive and this is an excellent workbook with proper letter progression according to the shapes each letter makes and the strokes required. Highly recommended.

I'm really disappointed with how small these are. They cover each letter and a few connections but that's about it. For the cost they should be much, much longer. I bought two copies for my kids to try in lieu of repeating the Handwriting without tears cursive book, but that one is significantly more comprehensive. This is a fine book for maybe two or three dollars, but as it is now it's completely overpriced.

Despite the lower ratings, and negative comments, I chose to purchase this item. I have NO regrets. If they seemed dry to others, then they were not familiar with chalk markers. You must allow the the liquid chalk to be absorbed into the tip. Follow the directions properly and they will work perfectly!!! have used these on several different chalk boards within just 2 days. If properly cleaned they absolutely do come off. I have a board that gives me some difficulty, but if cleaned with a mix of dawn and vinegar there is no ghost of the writing or it's color. I truly love this product!

This handwriting for beginners cursive book was great for my niece as a Christmas gift. She was in 3rd grade at the time she received this and she loved it. They no longer teach cursive to the elementary students at her school, so it was a great alternative for getting her educated in the skill of cursive. It is sturdy and well made. It is built to take some beating from hyperactive children. This book is really fairly priced. If you or anyone you know has a child wanting to learn to do cursive, this book is perfect for the job. I would recommend to anyone!

This workbook was a little disappointing for Jr High (6-8th grade). I would recommend it for the

lower grades, because it is very basic. I think even as low as 2nd grade could use some of these simple worksheets. But, by the time students reach the grades it recommends, I think it is useless and I had to find other resources.

My second grader was very disappointed to find out that she wouldn't be learning cursive writing in school. She asked for cursive writing workbooks for her birthday so she can teach herself. The book is good quality, and has lots of lines for tracing and then practicing the letters and words. My daughter was thrilled to receive this as a gift and can't wait to get started.

This workbook was recommended by our 3rd grade teacher and we like it a lot. Stories are short but interesting and educational. Great analytical questions. There is answer key at the end.
