

I'm only about 1/3rd of the way through this book, and I'm SO impressed I have to give it 5 stars already. It has already answered all my questions, and taught me SO much. I have found it easy to read - especially the first chapters. I'm not sure anyone could have possibly made the more confusing topics any easier to understand. For the classify workers portion, it's well organized so you can see exactly which organizations you need to be concerned with satisfying - and it's many more than just the IRS (in fact the one most likely to audit you isn't even the IRS!). It even tells you which are more likely to audit you. It lists what can trigger audits. It even lists the tests that each state uses in detail!!! This is perfect! I love the examples, and the tips for avoiding problems. If you want to get ICs, if you want to be an IC, or if you were treated as an IC possibly improperly in your last job and are disgruntled - you need this book! It even comes with forms and contracts on a cd and tear-out! Plus detailed suggestions on language for creating your own custom agreements.
